The Client agrees to the following terms and conditions:

- The Client will provide all required leashes, harnesses, muzzles, jackets and collars.
- The Client agrees to provide LTWL with one Pet Profile per animal. It is up to the Client to notify LTWL of any medication, behavior, or other pertinent updates. If these changes are not communicated to LTWL, LTWL is not liable for any consequences of these changes.
- The Client will pay the LTWL at a rate of **\$18** per half hour visit,, **\$24** per hour visit,, and **\$45** per “Adventure Time” (a 90 minute to two hour visit with your pet).
- LTWL will be paid on Friday for all services rendered earlier in the week. LTWL accepts Visa, Master Card, and American Express. Credit cards are subject to a 4% transaction fee. Checks can be made out to Lindsay Ryan and subject to a \$40.00 charge for all returned checks. Payment can also be made via PayPal, Venmo, or Zelle by sending funds to LTWL.lryan@gmail.com. If Client wishes to pay cash, arrangements will be made ahead of time with Lindsay Ryan.
- If payment is not received by the stated deadline, LTWL has the right to suspend services until the account balance has been rectified.
- The Client agrees to a 2.5% increase in service fees annually.
- The Client relinquishes rights to any pet photos or video taken by LTWL. LTWL can utilize the aforementioned photos on the company website, social media, print materials, or other public resources.

LTWL agrees to the following terms and conditions:

- LTWL will walk all dogs in the household for 30 / 60 / 90 / 120 minutes per session. Sessions will take place on Mon / Tues / Weds / Thur / Fri / Sat / Sun in the morning / afternoon / evening . Sessions will occur ___ time(s) per day.
- LTWL will provide Pet Nanny’s phone number to Client. Pet Nanny will respond to calls and/or texts within a reasonable time frame.
- LTWL and its employees will keep secure and confidential any keys, passcodes, access numbers and personal information, and return all relevant items at the end of the contracted service date.
- LTWL will supply disposable waste bags and pick up after the dog(s) while on a walk.
- For safety reasons, LTWL will not walk any dogs when temperatures are below 15 degrees Fahrenheit or above 85 degrees with high humidity. LTWL will stop by as scheduled for potty breaks and will spend the specified amount of time interacting with the dog(s) indoors.



Emergency Pet Hospital Protocol

In the event of an emergency or immediate medical need, Lindsay Ryan will be notified and is authorized to decide whether a vet visit is necessary (In the event of serious physical trauma such as broken/dislocated limb or laceration, pets will automatically be taken to the nearest emergency pet hospital). The pet owner will speak with Lindsay Ryan directly and the pet, if not already in the care of Lindsay Ryan, will be met at the hospital by Lindsay Ryan. Client agrees to reimburse LTWL for any expenses incurred while attending to this need within *two weeks of the incident*.

Release/Waiver

As the client, I release and hold LTWL harmless should my home suffer any damage not due to any negligence of LTWL. This includes any damages and destruction of property caused to my home by my pets. I further agree to pay for/reimburse the cost of any and all veterinary expenses and other reasonable service costs that LTWL may incur. Further, I attest that my pets are up-to-date on all vaccinations and will provide documentation of such. I attest that my pets do not suffer from any life-threatening or contagious conditions that may either be exacerbated by exposure to other pets, or expose other animals to undue risk while in LTWL's care.

Understanding the risks as stated above, I freely and voluntarily enter into this contract, including the release and waiver, with LTWL. This contract is a full and complete. Any violation of the aforementioned terms will be considered a breach of contract.
